VII. ACT 360 Northshore Technical Community College Lacombe Campus. Outdoor Classrooms

Mr. Brown noted that the LCTCS Facilities Corporation completed construction of the 30,000 square foot STEM Center building in Lacombe in January 2017. Northshore Technical Community College has acquired funding to construct two outdoor classrooms on the site of the Lacombe Campus. One of the classrooms proposed for construction will be adjacent to the STEM building and the college requests LCTCS Facilities Corporation Board approval to attach the structure to the STEM building by an overhang and walkway.

On motion by Director Boissiere, and seconded by Director Thibodeaux, the Board voted to approve the request from Northshore Technical Community College to attach an outdoor classroom structure to the STEM Center building in Lacombe, which was constructed using Act 360 funds. The motion carried.
