1. GMP Early Release Package 3 – Finishes, Special Systems and Associated Work to Complete 100% Construction Documents

REASON: GMP Early Release Package 3 consists of Finishes, Special Systems and Associated Work to Complete 100% Construction Documents, including Concrete Finishes, Flooring, Plastic Laminate Faced Cabinets, Waterproofing, Firestopping, Doors, Frames, Hardware, Metal Stud Framing, Drywall, Ceilings, Insulation, Signage, Equipment, and Mechanical, Electrical and Specialty Systems.

GMP PRICING: \$11,561,272.00

Mr. Budd reported that the Advisory Committee met on November 9, 2021 and evaluated seven (7) responses to the Request for Qualifications for Construction Manager at Risk (CMaR) Services for the Delgado Community College Center for Hospitality and Culinary and Workforce Building. Landis Construction Co., LLC received the highest average score and recommendation from the Advisory Committee.

On motion by Director Boissiere, and seconded by Director Montgomery, the Board voted approve Landis Construction Co., LLC for Construction Manager at Risk (CMaR) Services for the ACT 360 Delgado Community College, Center for Hospitality and Culinary and ACT 360 Delgado Community College, Workforce Building (former Blair project).
